Who qualifies?

1. Must be a NICA member.
2. Must compete in 3 NICA sanctioned competitions or more.
 - You can only use **one team score**.
 - This year you **are not required** to compete at the U.S. Nationals
4. Must submit scores from each event to the NICA office.
5. Must be a bronze medal sculptor and eligible to compete in the U.S. Nationals.
6. Participant may be an amateur carver.

Rules:

1. This years tour season will run from March. 1, 2009 to March 1, 2010.
2. If there are no Nationals for a year the Board of Directors will assign a final date and competition to announce the tour winner. This event will require the tour participants to attend. (This will replace the nationals on the tour list.)
3. We will take the three top scores from every competitors list and add the point totals. Highest point winner is the Tour Champion. You are allowed to attend as many events as you like, only three will be counted. You may only use one team score and the other two must be individual scores
4. After every event the participants are required to fax in their scoring forms to the NICA office. You will have two weeks to do this. If you do not send in the forms to update the listing, your score will not count.
5. You may use as many individual scores from NICA sanctioned competitions as you like, only one team score are is eligible. Scores found to be falsified will cause the competitor removed from the tour list and not eligible for prizes that year.
6. The tour fee is due when you submit your first score.
7. NICA board of directors will serve as the committee to regulate the tour.
8. Prizes will pay from first to third place. First place will be declared
